



d) Secretary: - Means Secretary of KBA Alumni Association Chandwad, Tal.Chandwad, Dist Nashik.

e) Treasurer : - Means Secretary of KBA Alumni Association Chandwad, Tal.Chandwad, Dist Nashik.

f) Member:- Means Member of KBA Alumni Association Chandwad, Tal.Chandwad, Dist Nashik.

2) AREA OF OPERATION: - All Maharashtra.

3) ACCOUNTING (Financial) YEAR: -

The Financial year of the Society shall be 1st April to 31st March of every year.

4) MEMBERSHIP AND PROCEDURE OF ENROLMENT: -

Student who has passed form SNJB's Smt K.B.Abed homeopathic medical college, Shri.R.P.Chordiya Hospital and Bhamashah Shri.V.D. Mehta (Dev-Vijay P.G.Institute of Homoeopathy, Chandwad, Dist Nashik 423101 Who agree with the aims and objects of the society will be allowed after consideration and approval of Executive committee. Executive committee keeps the right to reject any application for membership with giving specific reason.

5) KINDS OF MEMBERSHIP: -

A) Life Member : Student who has passed form SNJB's Smt K.B.Abed homeopathic medical college, Shri.R.P.Chordiya Hospital and Bhamashah Shri.V.D. Mehta (Dev-Vijay P.G.Institute of Homoeopathy, Chandwad 423101 and Who agree with the aims and objects of the society will be allowed after consideration and approval of Executive committee as a member by paying Rs.500/- as one time membership registration fee.

B) Honorary membership : Eminent person of medical faculty may be admitted to be honorary members of the Association by the Executive Committee of the Association.

- 6) TERMINATION OF MEMBERSHIP:-**
A person shall ipso-facto to cease to be a member and shall be removed as such by the Executive committee.
- a) On his/her death.
 - b) On his/her resignation of Membership.
 - c) On his/her convicted of criminal offence involving moral turpitude.
 - d) If he/she fails to pay his subscription for more than two years.
 - e) If he/she breaks the Rules and Regulation of the Society.
 - f) On his/her unsound mind and is so declared by a competent court.
 - g) On his/her undischarged insolvent.
 - h) Is found to be guilty of misconduct by the State Government, has direct or indirectly interest in a loans or any other transaction to be property vesting in the committee.
 - i) when the member is consistently absent for three meetings.

7) ANNUAL GENERAL BODY MEETING, ITS POWERS & FUNCTIONS

The General Body Meeting of the society shall be held once in a year within 90 days immediately after 31st March of every year at such place, time and date as Executive committee shall determine.

The power and functions of the general body meeting shall be

- i) To confirm the minutes of the previous Annual General Body Meeting.
- ii) To adopt the previous years audited statement and documents.
- iii) To elect the Executive committee for the next terms, if the term is over.
- iv) To admit new members as per decision taken by the Executive committee.
- v) To appoint Advocate / Legal Adviser, Chartered Accountant and fix their remunerations.
- vi) To consider any other matter, due notice should be given 15 days prior to the General Body Meeting.

8) NOTICE OF GENERAL BODY MEETING AND QUORUM:-

a) Notice of General Body Meeting. - Fifteen clear (15) days notice specifying the place, date, time with agenda shall be given to each and every member of the society, by suitable mode to in person or to their registered address.


b) Quorum of General Body Meeting. - The quorum for the General Body Meeting shall be 3/5 of the members of the society on record. Any adjourned meeting for want of quorum shall be held half an hour later at the same place and the members present shall form the quorum. But no business other than that specified in the notice shall transacted at such meeting.

9) EXTRA ORDINARY GENERAL BODY MEETING & ITS FUNCTIONS

An Extra Ordinary General Body Meeting may be conveying by the Executive committee of its own motion, or upon a requisition made in writing by

President and/or any 3/5 members of the society. Such requisition shall specify the subject of the meeting proposed to be called and must be signed by all the requisiteness and shall be delivered at the office of the society.

- 10) **EXECUTIVE COMMITTEE, OFFICE BEARERS:** -
The Management and administration of the said society shall be carried out and managed by the Executive committee which may pay all legal expenses incurred in promoting and registration of the said society, are mentioned herein these rules and regulations and specifically required to be exercised by the committee in general body meeting. There shall be Minimum Seven (07) and maximum Eleven (11) Members in the Executive committee.

The Executive committee shall be constituted of the following members President-1, Vice-President-1, Secretary-1, Treasurer- Other members.

- 11) **TERM OF EXECUTIVE COMMITTEE AND PROCEDURE OF ELECTION OF OFFICE BEARERS.**

Tenure of the Executive committee shall be for five years at a stretch, after the expiry of five years every individual of the Executive committee shall be eligible for re-nomination and re-election.

President, Vice-President and the Secretary of the society shall be elected from amongst the member of the Executive committee after every five years. Every election for the above purpose shall be based on the democratic pattern.

- 12) **OFFICE-BEARERS OF EXECUTIVE COMMITTEE AND THEIR DUTIES:** -

1) **PRESIDENT:** -

The President of the Society shall preside over the meeting and regulate all the meeting of the Executive committee. The President shall in addition to his Rights of voting as a member has a casting vote in case of tie. To conduct the meetings. To guide office-bearers regarding day-to-day routing work of the society.

2) **VICE-PRESIDENT :**-

The Vice-President shall assist the President in his day-to-day activities and shall perform his duties in his absence.

3) **SECRETARY:-**

a. To arrange all meeting in consultation with President and maintain records of all correspondence, registers and book pertaining to management and administration of the institution of the society.

b. To administer and control the finances of the institutions with the provision made in the budget subject to rules, terms and conditions of sanction.

- c. To sanction payments of salaries, increments and leaves of the employees of institution and to sanction payment for other services and materials against expenditure, authorized by the executive committee.
- d. To prepare the annual budget for presentation to the committees.
- e. To prepare the institution and also the society in cases relating to institution in all legal proceedings and to sign and verify pleadings on their behalf in such proceedings or cases.
- f. To submit for audit by the authorized auditors, all accounts, registers vouchers, receipts and other papers necessary for audit work.
- g. To copy and maintain accounts and spend the funds of the society under the guidance and control of Executive committee.
- h. To perform all the duties hereinbefore directed to be performed by the secretary and all such other duties as usually pertain to the office of secretary not specially provide by these rules and regulations.

4) Treasurer :-

- a. All types of cash transaction maintain day to day in office. To maintain day book and its related records and keep all legal records for audit purpose. To work as Accountant and to be responsible for all money-received units they are credited in the Bank.
- b. Decision of receipt and payment of society. To control over all its branches, Executive committee and arrange the meeting. To sanction the expenditure bills and to look after the property of the society. All financial Rights operated by secretary to issue proper receipts for them.

5) EXECUTIVE COMMITTEE MEMBERS: -

The members shall attend all the committee meeting, General Meeting they have right to vote at the time of election and to hold in the regular work of the society. They shall actively participate in deliberation as agenda. They shall assist, advice, suggests, guide and co-operate with other members of the committee for proper discharge of their duties jointly and severally. They shall be bound to offer any service to the betterment and uplift of the society.

13) MEETING OF THE EXECUTIVE COMMITTEE AND MEETING ON REQUISITION.

Minimum four meetings of Executive committee be called within year. On demand of 2/3 members of committee President can call a meeting within 15 days. If the secretary has not called meeting the President should call the meeting at the head quarter. The same meeting is called as demand meeting and mention specifically in the agenda.

14) NOTICE OF MEETING OF EXECUTIVE COMMITTEE & QUORUM

The notice of the Executive committee meeting shall be issued by the President or by the secretary before seven days. 2/3 members present in the meeting shall form a quorum of the Executive committee. If meeting is adjourned for want of quorum shall be held an hour later at the same place and members present shall form the quorum.

15) RULES OF ELECTION OF EXECUTIVE COMMITTEE:-

The procedure of the Executive committee election will be carried out in the following manner.

- a) The old Executive committee will be first appointed an election officer at least two month before the election of the new Executive committee. The Said election officer will act as a presiding officer and will supervise election proceedings at the General Body Meeting and conduct the same as per procedure announced by him for the election the said procedure must conform to the procedure laid down by the Executive committee.
- b) The Rules and Regulation laid down by the Executive committee for the election to the Executive committee will be binding upon the election officer.
- c) The tenure of the election officer will be reckoned from his date of election till the completion and formulation of the new Executive committee by the General Body. As soon as the new Executive committee formed his tenure will come to an end. The election officer will perform his duty fairly and impartially should he commit an act contravention of any provisions of election procedure, he will be forthwith discharged from his post by existing Executive committee.

16) FILLING OF VACANCIES OF EXECUTIVE COMMITTEE:-

If by death, resignation or otherwise or post the Executive committee happens to fall vacant, Executive committee will have the power to co-opt Member from General body within a period of one month from the date of the occurrence of such vacancy. The Executive committee will apprise of the said action at the next General Body Meeting. If the post is vacant for more than six months, Then the Hon'ble Asst Charity Commissioner Nashik shall have right to fill up the said post.


17) POWER AND FUNCTIONING OF EXECUTIVE COMMITTEE:-

The Executive committee shall work and have full powers and authority to do all acts, matter, things and deeds which may be necessary or expedient for the purpose of and in particulars to the following.

- a) To look after, manage, supervise and control the management of the said society and its properties.

- b) To admit or reject new members and accept resignation of the members.
- c) To have an audited statement of accounts prepared every year for submission to the office of the Asst. Charity Commissioners and any other authority as may be required as the Law for the time being in force, if any.
- d) To accept donations in cash or in kind.
- e) To appoint committee with such powers as the Executive committee may think fit and proper, for such purpose and dismiss the same when the purpose is full-filled.
- f) To make and appeal to the people for general donation as per the decision of the General Body.
- g) Generally, to do all such other acts, things as the incidental or conducive to the attainment of the above powers and duties or any one or more of them and the aims and objects specified in the Memorandum of Society.
- h) To do regular audit of accounts and to consider the audited statements of accounts.
- i) To purchase, exchange, lease or hire or otherwise howsoever and land building easements, Rights of common or privileges for the purpose of the society, providing that in the opinion of the managing body any condition attached to the gift or donation is not onerous, against the object of the trust or in any other manner objectionable or in otherwise on order.
- j) To borrow or raise money / loan as may be required for the purpose of the society, upon security bonds, debentures, promissory notes or other obligations or securities of the society or by mortgage or charge on the property of society.
- k) To create posts and make appointment on such terms as it may in its absolute discretion, decide fill vacancies, direct transfers, retirements and give promotions, increments, honorarium and grant leaves also extension of service to any officer of any employee of the society, and to do all such acts and things may be necessary for the day to day working of the society.
- l) To delegate powers of any one of them, or to any other person whether member or not of the society as may be necessary for the proper functioning of the society.
- m) To make rules and regulation for carrying out the aim and object of the society.
- n) To collect, receive, distribute, invest, dispose of expend, covenant, or otherwise deal with the funds and properties of the society for the purpose of the society.
- o) To co-opt two more members to the Executive committee provided however that the total number of members shall not exceed Eleven at a time and the co-opted members on board shall not exceed two at a time

and co-opted members shall have the same powers and duties as other members.

- p) To appoint new member to fill in vacancies caused by resigns or dies or refuse to act.
- q) Society shall apply for benefit under section 80-G exemption for Income Tax who are giving donation to the society.
- r) A committee may by resolution appoint such sub committees as it may deem fit and may delegate to them such powers and duties as it specifies in the resolution and a committee or sub committee may arrogate.

18) FUNDS AND INCOME OF THE SOCIETY OR ITS UTILISATION:-

Society shall raise their funds by way of subscription, contribution, membership fees, grants, bank interests, donation in cash or in kind etc.

19) OBJECTIVE BASED PROVISION FOR EXPENDITURE:-

The fund of the society should be used for the fulfillment of the objects of the society as specified in the Memorandum of Association and administration of day to day activities of the society.

20) PROVISION FOR LOANS AND DEPOSITS:-

Executive committee shall have power to keep society Deposit in a scheduled bank or nationalized Bank and also it shall have power to raise loans any bank or interest free loans from any individual body or institution for the requirement of the society by taking prior permission of the Joint Charity Commissioner, Nashik.

21) PROVISION REGARDING PURCHASE AND SALE OF IMMOVABLE PROPERTY:-

The management, achieving the target of the society for administration of the society at the society shall sale or purchase any immovable property in the name of the society. However society shall obtain the prior permission of Joint Charity Commissioner Nashik Region to do sale of immovable property of the society and all the transactions shall be in accordance with the existing laws of the land. Society can also obtain immovable property by way of will, gift from any person or institution.

22) OPERATION OF BANK ACCOUNT AND OTHER FINANCIAL MATTER:-

All funds of the society shall be held in any Nationalized or approved co-operative bank or private bank in the name of society. The bank account of the society will be operated by President / Vice President & Secretary under the joint signature.

23) MAINTENANCE OF REGISTER OF MEMBERS:-

A up-to-date register of members who are members within the meaning of section 15 of the societies Registration Act, 1860 will be maintained in the form of schedule VI to the societies Registration (Maharashtra) Rule, 1971 vide Rule 15 thereof. This membership Registrar shall be produced at the time of General Body Meeting for the verification of the General Body.

24) PROVISION FOR AMENDMENT IN RULES AND REGULATION:-

Any change in the memorandum and / or rules and regulation can be resolved by minimum 3/5 votes of the Managing body in Special General Meeting and the same change/amendment shall be submitted to the Charity Commissioner for obtaining his sanction. This shall be as per the provision of section 12 of society's Registration Act, 1860.

25) PROVISION FOR CHANGE IN THE NAME AND OBJECT OF THE SOCIETY:-


Name and / or objects of the society shall be changed/ amended by minimum 3/5 of the votes of the members of managing body in Special General Meetings and it shall be submitted to the Charity Commissioner to obtain his sanction. It shall be as per the provision of according to Section of 12 and 12A of the society's registration act 1860.

26) DISSOLUTION OF THE SOCIETY:-

Dissolution of the society shall take place in accordance with the section 13 and 14 of the society Registration Act, 1860. The Society can be dissolved minimum 3/5 votes of the members of the trust, in general meeting.




