



Daga also said regarding continuous head should be vary according to course and both were proposed seminars can be conduct in practical session. Dr. V. A. Chatpalliwar proposed in the assignment head, students should prepare some models or charts according to course. So, it was decided that, for continuous mode of theory course teacher will decide 2 heads according to course.

Dr. V. A. Chatpalliwar proposed Proposed 3 heads i.e. synopsis, viva voce and laboratory record for continuous mode of practical for the first year B. Pharmacy (semester-I) and second year B. Pharmacy (semester-III).


